### Commercial & Industrial Prescriptive Lighting GO Program

#### Primary Objectives

MMWEC's Green Opportunity (GO) Program assists Massachusetts municipal utilities in developing and delivering energy efficiency services to their commercial and industrial customers.

- Provide a streamlined process for the review and installation of lighting improvement retrofit projects in existing commercial, industrial, governmental, and institutional buildings.
- Assist **Ashburnham Municipal Light Plant's** customers to reduce operating costs by incentivizing the identification and installation of cost effective lighting improvements.

#### Program Summary/Design

**Ashburnham Municipal Light Plant's (AMLP)** Prescriptive Lighting GO program will be a fast track process for reviewing and implementing lighting projects. This program is for customers who have identified lighting improvement projects and have procured cost quotations from licensed installers. Incentives available through **AMLP's** Prescriptive Lighting GO program are based upon equipment eligibility and pre-determined incentive per unit.

Below is a detailed summary of the program process from project eligibility to final delivery of the incentive from **AMLP**.

1. **Project Eligibility:** Equipment must be new and installed in a commercial, industrial, institutional, educational, or municipal building, or in common areas of a multi-family building (> 4 units) in the service territory of **AMLP**.
2. **Equipment Eligibility:** The exact product types listed on the application form are eligible for prescriptive incentives. See our comprehensive Lighting Guide for more information.
3. **Application:** The customer or their contractor should complete the Prescriptive Lighting GO Program Application Form, available on the **Ashburnham Municipal Light Plant** website or [www.mmwecgoprogram.org](http://www.mmwecgoprogram.org), in its entirety and return to the program administrators by any of the methods listed on the application form. The application will be reviewed for completeness. Incomplete applications will delay the review and incentive payment, please be sure to provide all the required information. Application must be signed and dated by customer. **Note: Incentives capped at 50% of installed project costs.**
4. **Review Process:** The review process begins once MMWEC GO has received all of the required information. On average, this may take several weeks depending on the complexity of the project. MMWEC GO Program administrators may contact you to ask questions or obtain further information. If an application meets the program criteria, a **Pre-Approval Incentive Letter** is sent to both the participant and contractor for the project.

<p><b>Program Summary/Design</b></p>	<p>5. <b>Pre-Approval Required:</b> Before you purchase and install the equipment, send the following to MMWEC GO Program in order to receive a “Pre-Approval Incentive” letter:</p> <ol style="list-style-type: none"> <li>a. Your application with all requested information filled in.</li> <li>b. Manufacturer’s technical specification sheets (“cut sheets”) for each type of eligible equipment purchased.</li> <li>c. A W9 form for the intended recipient of the rebate.</li> <li>d. After you receive Pre-Approval Incentive Letter and have purchased and installed the qualified equipment, return the following to MMWEC GO Program: <ol style="list-style-type: none"> <li>I. A signed copy of your “Pre-Approval Incentive Letter.”</li> <li>II. A copy of your invoice showing the date and place of purchase and model/part numbers of the equipment installed.</li> <li>III. If actual installation numbers differ, please submit a revised application.</li> </ol> </li> </ol> <p><b>Please note: In order to receive an MMWEC GO Program incentive, invoices and manufacturer’s technical data sheets (“cut sheets”) will always be required.</b></p> <p>6. <b>Post Installation Inspection:</b> All projects requesting an incentive of \$2,500 or greater are subject to a site inspection. MMWEC GO Program will contact the participant to set up a convenient time for the site inspection. Other projects will be randomly assigned a site inspection at the discretion of MMWEC GO Program.</p> <p>7. <b>Incentive Payment:</b> An incentive check will be issued for all projects that successfully meet the parameters of the program. See below for more information about financial incentives.</p>
<p><b>Target Market</b></p>	<p>All non-residential customers – commercial, industrial, governmental, and institutional. Customers must be in <b>good financial standing</b> with <b>AML</b>P to participate in the program.</p>
<p><b>Target End Uses</b></p>	<p>Target end uses include all lighting retrofit projects that result in energy savings, including: LEDS, lighting controls, and advanced lighting projects. LED products must be qualified as specified in the lighting system and eligibility requirements table in the application form.</p>
<p><b>Financial Incentives*</b></p>	<p>The exact product types listed on the application form are eligible for prescriptive incentives. See our comprehensive Lighting Guide for more information.</p> <ul style="list-style-type: none"> <li>• Each business is eligible for <b>incentives capped at 50% of project</b> costs, up to a combined \$5,000 per business, per calendar year, across all MMWEC GO Programs offered by <b>AML</b>P.</li> <li>• MMWEC GO Program has the right to monitor and/or inspect the installation and energy use of the products for which incentives are paid.</li> <li>• MMWEC GO Program may publicize your participation in this program, unless otherwise requested.</li> </ul> <p><b><i>*This offer may be changed, revised, or discontinued at any time by MMWEC GO Program.</i></b></p>

**Delivery Mechanism**
